Clarification Nº 2

Question 1: We would like to know whether the forms can be adapted to the layout of our firm but, of course, with the same information and fields to be filled or they have to be exactly the ones shared on the TOR to be submitted?

Answer CADP Nº 1: As indicated in the Procurement Document that includes the Terms of References and Instructions for the Bidders, Expressions of Interest shall be presented in the format using Forms I, II, III and IV.

Question 2: Since we don't have the required Forms in writing formats, only in PDF format in the TOR, could you please send them to us for easy filling?

Answer CADP Nº 2: The required forms (Forms I, II, III and IV) are provided in pdf format.

Question 3: In regards to this tender, we asking for 30 days' extension as we need to build our team.

Answer CADP Nº 3: As mentioned in the Procurement Document, section 1 - Letter of Invitation, paragraph 6: *Expressions of Interest (EOI) shall be submitted in English, using Forms I, II, III and IV that are part of the TOR and must be delivered in a written form to the address below (in person, or by mail, or by e-mail) by the deadline of February 24, 2021.*

CADP would like to remind the potential bidders that at this first phase, eligible firms/joint ventures shall supply information which demonstrates their required qualifications and relevant experience to perform the Services; thus, no technical nor financial proposals shall be presented now.

Question 4: As part of this competition for "MONITORING AND EVALUATION CONSULTING SERVICES FOR PDAC REFERENCE No. REoI Ref: 101/CS/CADP/20", which we are evaluating, we would like to clarify the following points:

- a) does the entity submitting the proposal have to be an Angolan entity?
- b) the costs associated with the technological component necessary for the logistics of surveys on the ground will be cost borne by the Consultant?

Answer CADP Nº 4:

a) As stated in the announcement launched under this tender and in the Procurement Document, section 1. Letter of Invitation, paragraph 2: *"The CADP invites eligible Firms to indicate their interest in providing the Services by supplying information which demonstrates their required qualifications and relevant experience to perform the Services. ..."*

Consequently, any eligible firm is invited to participate in the said tender and present its candidature/expression of interest.

b) Yes. All costs shall be covered by the Consultant.

As above mentioned, at this phase no proposals (technical or financial) are presented; thus, this concern shall be for phase 2 (Request For Proposals) of this tender.
