**Question 3:** The EoI form II should be completed by the consortium or by each member of the consortium?

**Answer CADP Nº 3:** As per the announcement, paragraph 4 "Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy....." Additionally the EOI FORM II is related to the CURRICULUM VITAE OF THE CONSULTANT (FIRM); consequently, if it is an association of firms/consultants, it is clear that information of its members shall be presented for evaluation.

**Question 4:** Concerning to the Expression of Interest for CADP, we would like to confirm that the only CV's that will be evaluated in this stage are "Key Professional Staff".

**Answer CADP Nº 4:** At this phase, key experts' Curriculum Vitae will not be evaluated.

**Question 5:** In this sense it's not necessary to present on the Expression of Interest the "non-key professional staff" and the "non-key professional survey staff".

**Answer CADP Nº 5:** Please see Answer Nº 4 above provided.

**Question 6:** We also need to confirm if it's necessary to submit any administrative document and which.

**Answer CADP Nº 6:** We inform that information for presentation of Expressions of Interests are clearly stated under this Procurement Document that includes the TOR. Additionally, eligible Firms to indicate their interest in providing the Services shall supply information which demonstrates their required qualifications and relevant experience to perform the Services.
